1. RANGE LOCATION: The Ben Avery (Black Canyon) Shooting Facility, 25 mi. North of Phoenix, AZ.
½ mile West of I-17 on the Carefree Hwy (SR74). (Exit 223).
2. FACILITIES: A Camping area, with water & toilet facilities, is available, during the matches, for competitors only. Competitors are responsible to provide their own food and water.
3. RULES: Current CMP High Power Rifle Rules shall apply.
4. ELIGIBILITY: All competitors must be paid up members of the ASRPA. (annual \$25.00 for adults, \$10.00 for juniors). If a competitor does not wish to join the ASRPA he/she may pay a \$5.00 match membership fee. **All competitors must show their membership card at the stat office when they are obtaining their squadding or pay the 5.00 match membership fee.**
5. ADVANCE ENTRIES ARE REQUIRED: All entries must be paid in advance.
6. INDIVIDUAL ENTRIES: Make entry in individual events on enclosed Registration & Entry form. Entries MUST be accompanied by check or money order made out to **ASRPA JR Rifle Team**. Mail to: ASRPA Matches, 5010 E. Restin Rd., Cave Creek, AZ 85331. Fees paid by those unable to attend will be refunded upon request, less a \$10.00 service fee, providing cancellation is made prior to 6:00 PM, Tuesday, 6 Jan., 2026. There will be no refunds for those canceling after that time. You may also enter on line at Desert Sharpshooters.com.
7. ENTRIES CLOSE: 6:00 PM Tuesday, 6 Jan., 2026. Entries after this time are considered late entries and may be accepted to fill vacancies on existing relays only. An additional \$20.00 will be charged for late entries.
8. ENTRY LIMITS: 180 Individual entries.
9. FEES: All indiv. matches Fri., Sat.

Military teams must make advance arrangements to pay match fees.

Reminder: Everyone who is not a current paid up member of the ASRPA must select one of the following options:

- a. Those wishing to be a member of the ASR&PA may do so by submitting appropriate fees (\$25.00 for adults; \$10.00 for juniors).

OR

- b. Those not wishing to be a member of the ASR&PA must pay a \$5.00 one-time match membership fee.

LATE ENTRY FEE: \$20.00 additional.

CHALLENGE FEE: \$3.00 The challenge fee must be paid at the time the challenge is requested.

10. PRACTICE FIRING: The match fees do not include Range fees for individuals practicing before the match.

11. TARGETS: SR at 200 yards., SR-3 at 300 yds., MR-1 at 600 yds.

13. TARGET SERVICE: All firing will be on Shot marker electronic targets. Competitors are encouraged to provide their own tablets or phones.

14. EMPTY CHAMBER INDICATOR (ECI): Approved CMP empty chamber indicator is required to be used at all times except during the preparation period and firing of your relay. Those not having an ECI may purchase one at the stat. office for \$1.00 each.

15. SQUADDING: All matches will be squadded. Squadding tickets for individual matches will be issued at the Stat. Office starting at approx. 7:30 AM on Friday 9 January, Saturday 10 January, and Sunday 11 January. A competitor who fails to obtain his squadding ticket by 8:30 AM will only be squadded to fill up vacancies.

16. SCORING: Competitors will score. Any competitor failing to perform his scoring duties may be disqualified.

17. CLASSIFICATION: CMP High Power Classification will be used. Rule 4.10.6 "Current Classification" may be used. Those unclassified or without proof of classification, will be required to compete in the Master class. Please indicate classification on the registration & entry form.

18. DIVISION BY RIFLE: Match #1, #2, #3- Any Rifle (Division A), Palma Rifle (Division P), Service Rifle (Division S), F-Open (Division O), F-TR (Division T), Scope Only (Division Z) Matches #4,#5,#6,#7,#8 – Service Rifle (Division S), and NRA Match Rifle (Division M).

19. CATEGORIES: Service, (Includes Reserve, and National Guard), Civilian Service Rifle and Match Rifle.

20. AWARDS: Medals will be awarded to 1st, 2nd & 3rd place Sling, F-open & F-TR on FRIDAY. Awards will be presented on SATURDAY to Match Winner, High Junior, High Woman, High Senior and High Police/Military. SUNDAY awards will be for Match Winner, CMP Achievement Pins, and Grand Aggregate from Matches 1 through 8.
21. CHALLENGE PERIOD: The challenge period ends ½ hour after the posting of the match results.
22. RESULTS BULLETINS: Results bulletins will only be mailed to those people requesting them. The match results will be posted on the ASRPA web site.

MATCH SCHEDULE

FRIDAY, 9 January 2026, 9:00 AM

MATCH 1: 600 yds. slow fire prone, any sights, unlimited sighters & 20 shots for record, 22 minutes. MR-1 or F Class target.

MATCH 2: 600 yds. slow fire prone, any sights, two sighters & 20 shots for record, 22 minutes. MR-1 or F Class target.

MATCH 3: 600 yds. slow fire prone, any sights, two sighters & 20 shots for record, 22 minutes. MR-1 or F Class target.

SATURDAY, 10 January 2026, 9:00 AM

MATCH 4: 200 yds. slow fire standing, 2 sighters, 20 shots for record, 22 minutes.

MATCH 5: 200 yds. rapid fire sitting, 2 sighters & 2 ten-shot strings, rapid fire, sitting or kneeling, 60 seconds per string.

MATCH 6: 300 yds. rapid fire prone, 2 sighters & 2 ten-shot strings, rapid fire, prone, 70 seconds per string.

MATCH 7: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes.

MATCH 9: THE ARIZONA STATE CHAMPIONSHIP: Total score of Matches 1 through 8.

SUNDAY, 11 January 2026, 9:00 AM

MATCH 8: (CMP) Service Rifle EIC "LEG" Match.

1. OPEN TO: Any citizen of the United States 14 years of age or older.
2. RULES: This match is governed by the rules prescribed by the Civilian Marksmanship (CMP). (See CMP Competitions Rules & Programs).
3. ENTRY LIMITS: 180 competitors, priority to non-distinguished.
4. ENTRIES: ADVANCE ENTRIES ARE REQUIRED. Indicate on the enclosed registration entry form, and

mail with appropriate fees to: ASRPA Matches, 5010 E. Restin Rd., Cave Creek, AZ 85331. You must complete the OFFICIAL entry, the CMP Entry & Score Card. This must be obtained from the stat office by 8:30 AM Sunday, 14 January 2024

5. ENTRY FEE: \$30.00. Include this fee with Championship Match fees. (\$15.00 CMP "LEG" entry fee, plus \$15.00 range and service fees.)
6. ENTRIES CLOSE: This match may be entered at the range STARTING AT 7:30AM 11 January 2026. NBPRP Entry cards must be obtained from the stat. office prior to 8:30 AM, Sunday, 11 January 2026. After that time entries will be accepted to fill vacancies only.
7. AUTHORIZED ARMS: US Rifle Cal 30M1/M1NM; US Rifle Cal 7.62 M1/NM; US Rifle Cal 7.62 14/M14NM; Rifle Cal 7.62mm M1A, having not less than 4 1/2 lb. trigger pull, with standard stock and sights as issued; or the US Rifle Cal 5.56mm M16 series or commercial equivalent, as prescribed for use in the National Matches.
8. AMMUNITION: NOTE: Competitors must now furnish their own safe ammo having the following characteristics. Ammunition may be commercially manufactured or handloads. No flat tip or round nose. The projectile may have a "ballistic" hollow point such as that used in the current military M852 style, 168 grain, 7.62mm arsenal match round. These guidelines will apply to all authorized service rifle calibers, i.e., 7.62mm (.308), 5.56mm, and caliber .30 (30-06). There will be no restrictions placed on bullet weight or muzzle velocity. NO AP or Tracers allowed.
9. TARGET SERVICE: All firing will be on Shot marker electronic targets. Competitors are encouraged to provide their own tablets or phones.
10. SCORING: Competitors will score. Last relay will score Relay 1; Relay 1 will score Relay 2, etc. Competitors not performing their scoring duties will be disqualified.
11. COURSE OF FIRE: The National Match Course (50 shots) No Sighters.
Stage 1: Slow fire, 200 yds, 10 shots standing. Time: 10 min. SR Target. The sling must be attached to the rifle but must not be used for support.

Stage 2: Rapid fire, 200 yds, 10 shots with a mag change, sitting or kneeling from standing. Time: 60 seconds. SR Target.

Stage 3: Rapid fire, 300 yds, 10 shots with a mag change, prone from standing. Time: 70 seconds. SR-3 Target.

Stage 4: Slow fire, 600 yds, 20 shots, prone. Time: 20 minutes. MR-1 Target.
12. AWARDS: Credits toward Distinguished Designation and appropriate Excellence-in-Competition badges, as provided in CMP Rules.

BEFORE A PERSON MAY SHOOT CMP "LEG" MATCH THEY MUST HAVE A CERTIFICATE OF ELIGIBILITY AFFIDAVIT AND LIABILITY AGREEMENT ON FILE WITH THE ASRPR OR THEY MUST FILL OUT THE BACK OR FRONT OF THE ENCLOSED AGREEMENT.
